VACCINATION For the protection of your pet, Arnold Pet Station (APS) requires all boarders be current on the following vaccinations:

Dogs:

- Distemper/Parvo
- Rabies
- Bordetella
- Canine Flu (H3N8 & H3N2)

Other:

- Negative Intestinal Parasite Screen (Fecal) within the last 6 months. This requirement is to ensure that our kennel remains parasite-free.

Cats

- Distemper/Rhinotracheitis
- Rabies vaccines.

Both dogs and cats will be inspected for fleas on the day of entry to our kennel/cattery. If your pet has evidence of fleas, s/he will be treated. It is recommended that all pets with evidence of fleas be bathed; a bath will be required for any pet that is heavily infested. A nominal charge will be applied to your bill for these services. This will assure that your pet and all others will be free of fleas during the boarding period and when going home.

DIET

- We provide a premium Purina diet for all pets during their stay.
- Our staff will monitor your pet's appetite, urine and bowel habits, and attitude each day.
- ***If you choose to provide your pet's own food, please bring only the amount needed for their stay. Please package daily feedings individually in storage containers or plastic bags.***

MEDICATIONS

- Medication will be administered for a small fee. Injectable or complicated medications or treatments may incur additional charges.
- Must be brought in their original prescription bottles or manufacturer's container.
- Please advise us if your pet will need any refills of medications while staying with us.

BELONGINGS

- We do not accept bedding from home.
- Bedding is provided to those pets who do not chew.
- APS provides toys for play time, however you may also bring a maximum of TWO personal toys for your pet.
- We do not accept rawhides or toys that could potentially be destroyed or ingested.
- ***The Arnold Pet Station is not responsible for any personal belongings.***

BATHING

- If you are interested in having your pet bathed, please ask our staff for an estimate.
- Pets who are excessively dirty or matted or have excessive undercoat may be priced higher.
- Occasionally a pet may be sent home unbatched with the recommendation that they see a professional groomer.

Photography/Video consent

- Pictures or video of your pet may be taken while boarding, primarily while playing and may be used on our website and/or Facebook page.
- No personal information will be posted on either the website or Facebook page.

EMERGENCIES AND VETERINARY TREATMENT If your pet should become ill during the boarding period, our professional staff will examine and treat your pet as required. Should problems arise during non-business hours, transport to AAVEC in Annapolis may be required. You will be responsible for any charges incurred for medical services and treatment administered. Dogs with recurrent diarrhea will be examined for internal parasites. **All dogs found to have internal parasites will be treated at the owner's expense to prevent contamination of our premises. If your pet needs to be moved from the boarding kennel to the hospital, daily hospitalization charges may apply instead of the daily boarding rate.** We will make every attempt to contact you if this situation occurs.

Should my pet require treatment during boarding:

____ If unable to reach me or my authorized agent, I authorize only those treatments determined to be life saving where time is of the essence. I understand that fees for such treatments may climb into the hundreds or thousands of dollars.

CANCELLATION: If you must cancel your reservation, please give at least 72 hours notice. We reserve the right to charge a cancellation fee of \$25.00 for dogs and \$15.00 for cats if proper notice is not given. Initial _____

FEES - Boarding Fees are Subject to Change. Please ask a staff member if you have any questions about rates.

I understand the following:

- **Arnold Pet Station does not provide 24 hour supervision of boarding pets. There is a centrally monitored fire and security alarm system.**
- **My pet will only be released during regular business hours and all fees due for its care will be paid in full at that time. I agree I am responsible for all charges regarding my pet's care.**
- **Arnold Pet Station will not release my pet to a second party unless I have notified them in advance. If the second party does not provide payment, I understand that all fees will be charged to the credit card on file.**
- **If I neglect to pick up my pet within 5 days of receiving written notification the animal is ready for release, you may consider the animal abandoned and dispose of it as we see fit. I agree I will be responsible for all charges incurred for its care until disposal.**

NOTE: When your pet returns home, please do not allow him/her to eat or drink excessively. This is a common mistake that frequently results in vomiting and/or diarrhea from abrupt dietary change or stress. Wait at least one hour before giving a small portion of food or water. Please call if you have any concerns about your pet's health.

I agree to the terms and conditions of the Boarding Authorization. I understand that Arnold Pet Station will keep this form on file for my pets and its terms will be effective for all future boarding stays unless I notify Arnold Pet Station otherwise.
